#### **Data Protection: Debate in LIBE Committee, JURI Opinion adopted and discussions in the Council**

In the LIBE Committee, MEP Albrecht announced the vote will take place on 29-30 May in the LIBE Committee to leave time to all MEPs to analyse the around 3000 Amendments. The rapporteur reminded that this process is only a revision and that today's debate is deeply grounded in the 1995 directive.

On the day before on 19 March, the latest opinion to be adopted on Data protection was voted in the JURI Committee.

The committee expressed the results of the vote in a press release highlighting the debates on the "right to be forgotten" and a support to the Commission requirement for explicit consent before a person's data is collected.

Legal affairs specialists in Parliament support the "right to be forgotten" as proposed by the Commission in its draft data protection regulation. This would oblige companies, such as social networks or online shops, to delete personal data on request. For more information see the [Press Release](#).

However, the committee says in its non-binding opinion that this right should not apply to data processed for healthcare purposes. They believe that is important to retain complete health records in order to ensure the best care and treatment.

In the Council on 8 March the main discussions were about the obligation to engage in prior consultation with the supervisory authority based on a risk assessment and the obligation to have a data protection officer.

#### **Transparency: The Commission publishes amended proposal on transparency of pricing and reimbursement**

On 18 March, the Commission adopted an [amended proposal](#) on the transparency of measures regulating prices of medicines. The amended proposal includes various points of the Report of MEP ravanova (ALDE, HU) such as:

- The deadlines for pricing and reimbursement decisions of the European Parliament (180 days for drugs and 60 days for Generics) and a "stop-the-clock-system"
- The deletion of the award of damages and daily penalties
- The access of competent authorities to the data of the authorization procedure
- The possibility to assess relative efficacy in article 13
- Contractual agreements are excluded from the scope of the directive

### **Social Investment: “Investing in Health”: Health spending is 'growth friendly' expenditure**

Based on the social investment package, the “Investing in health” brochure follows and sums up the Staff working document (SWD).

The new [brochure](#) of DG Health and Consumers sums up why investing in health is interesting is important and reaffirms key principles to better invest in health. The brochure therefore focuses on sustainable health systems, human capital and health inequalities.

The study also summarises in a clear fashion EU health initiatives (See picture).

### **Active Ageing: Introducing Active Ageing Index**

A new Active Ageing Index (AAI) has been launched online by the European Commission and the United Nations Economic Commission for Europe (UNECE) aiming to enhance the availability of this new statistical tool to all its potential users. The index measures the extent to which older people can realise their full based on 4 main domains: employment, participation in society, independent living and ageing environment.

### **Mental Health: Launch of the Joint Action on Mental Health and Well-Being**

The new Joint Action, funded under the EU Health Programme, will be running from 1 February 2013 till January 2016 and coordinated by Universidade Nova de Lisboa in Portugal. The joint action will address: The promotion of mental health at the work place and in schools; Promoting action against depression and suicide; Developing community mental health care and Promoting the integration of mental health in all policies.

The expected result is a more rigorous and comprehensive knowledge on of mental health and well-being situation in the EU and the development of an endorsed framework for action.

### **Environment: MEPs call for better protection from hormone-affecting chemicals**

The resolution calling for a reduction in exposure to these chemicals was adopted on 14 March in Strasbourg with a large majority.

Hormone-related disorders have gone up over the last 20 years and one of the causes behind this could be endocrine-disrupting chemicals.

Swedish Social Democrat MEP Åsa Westlund, who wrote the report, explained: “*Even if we do not have all the answers, we do know enough to regulate these substances in accordance with the precautionary principle.*” Potential endocrine disruptors include for example steroid hormones, some pesticides, polychlorinated biphenols (PCBs), dioxins and plastic additives. ### **E-health: US and EU have published roadmap to work together on eHealth/health IT**

The European Commission's Directorate General for Communications Networks, Content and Technology (DG CONNECT) and the United States Department of Health and Human Services (DHHS) have agreed on a roadmap to strengthen transatlantic cooperation in eHealth and Health information technologies (IT).

This builds on a Memorandum of Understanding on this topic, signed in 2010 under the auspices of the Transatlantic Economic Council. Over the next 18 months the new roadmap will guide the activities of the collaboration focusing on two high priority areas: Standards Development and Workforce Development. This cooperation will be presented in the joint EU-US eHealth/Health IT Cooperation Assembly during the EU's eHealth Week, hosted by the Irish Presidency in Dublin Ireland on 13-15 May 2013. ### **Pensions: State pensions must guarantee decent living standards for all, insist MEPs**

In a resolution adopted on 22 March, the Social and Employment Affairs Committee stresses that safeguarding public pensions to ensure decent living standards for all in old age must remain a priority. They also call for the development of supplementary pension schemes and longer working lives to ensure the sustainability of pensions threatened by demographic ageing and strained public finances.

The resolution, drawn up by Ria Oomen-Ruijten (EPP, NL) and passed by 32 votes to 4, with 6 abstentions, is the employment and social affairs committee's response to the Commission white paper on pensions. The resolution

reminds that there are four people of working age for every person of retirement age and that in 50 years' time there will be only two to one. The Rapporteur declared: *"We need safe and sustainable pensions in all member states now and in the future. This is important for both young and old people. In the context of increases in longevity, declining birth rates and constraints on public finances, we are facing enormous challenges"*.

#### **Medical Devices: S&D Workshop on "Medical devices and In Vitro Diagnostic Medical Device"**

*On 19 March the Rapporteur Roth-Berendt organised a 2<sup>nd</sup> Workshop on Medical devices and In Vitro Diagnostic (IVDs) in the context of the current review of the dispositions.*

The workshop was chaired by MEP Roth-Berendt (S&D, DE) and speakers included notably representatives of Eucomed for the industry and of ESIP, the European Social Insurance Platform as well as the Belgian Healthcare Knowledge centre as well as the European Society of Cardiology.

The Rapporteur supports a Pre-market approval and a Change of notified bodies. Ms Dagmar Roth Berendt reiterated she favours a Pre-market approval for high-risk medical devices, considering to do it with a centralised authority.

The Rapporteur also clearly supports a legal basis for notified bodies and mentions public clinical trials

Dagmar Roth-Berendt wants to give a clear legal basis to notified bodies based on clear definitions.

Data mining, clearer rules of data protection, recruitment of experts and publication of names need to be looked at.

Dagmar Roth-Berendt seemed to oppose the contracting of external experts.

#### **European Mutual Statute: Adoption of the Own-Initiative Report on the European Mutual Statute**

On 14 March, the European Parliament adopted the Own-Initiative Report on the European Mutual Statute by Rapporteur Luigi Berlinguer in plenary sitting. The intervention of MEP Bérès can be watched online ([Video](#)).

AIM members organised a Cocktail on the European Mutual Statute on 13 March in Strasbourg hosted by MEP Pervenche Bérès (S&D, FR) and in the presence of MEP Berlinguer (S&D, IT).

Now more than ever AIM members stress that a European Mutual Statute is essential to renew a competitive and social Europe within the current economic and social environment. Indeed, the current legal instruments do not make it possible for mutual societies to develop, as mutuals, at the European level.

#### **European Mutual Statute: Public consultation**

*The public Consultation on Mutual Societies is running now and until 14 June 2013. All mutuals and federations are invited to reply to the public consultation.*

In some states, health mutuals and insurance mutuals are not allowed to operate due to the lack of existing legal framework, and have limited possibilities for cross-border activities with mutuals in other countries. The study contains details on characteristics, legal frameworks, corporate governance, and economic importance, as well on barriers that these enterprises face in Europe, when they wish to engage in activities across borders or to create groups.
